1. RANDOLPH COUNTY TRIPLE DUAL CRITERIA (Team Champion)

- a. If there is a tie in the dual meet score between two schools, we will use the criteria listed from the National Federation Rules. (Suggested Tie Breaker)
- b. If two or more teams tie with the best record on the day, the head to head match will determine the team champion.
- c. If head to head competition does not determine a champion, we will use the criteria approved by the Randolph County Athletic Association. (Amended 12/7/18)
 1. Greater number of victories Note: Forfeits, defaults and disqualifications count toward total number of victories.
 2. Combined total number of falls, forfeits, defaults and disqualifications.
 3. Total match points scored only from decisions, major decisions and technical falls.
 4. Total near fall points scored only from decisions, major decisions and technical falls. (Example: N-2 + N-2 + N-4 = Total of 8 near fall points scored for one team.)
 5. Total number of takedowns scored only from decisions, major decisions and technical falls. (Example: T-2 + T-2 + T-2 = Total of 3 takedowns scored for one team.)
 6. Least number of unsportsmanlike conduct calls.

2. RANDOLPH COUNTY TRIPLE DUAL CRITERIA (Individual Champion)

- a. Line ups will be locked in place for the day at the completion of weigh in. Wrestlers must remain at the same weight class all day. (Injury can allow for an alternate wrestler to be substituted. (Amended 12/9/16)
- b. An individual must wrestle all competitors in their weight class to be declared the Champion.
- c. If two individuals tie with the best record, the head to head match would determine the individual champion. (Amended 12/9/16)
- d. If head to head competition does not determine the weight class champion, we will use the criteria approved by the Randolph County Athletic Association. (1. Most Pins, 2. Most Technical Falls, 3. Most Major Decisions, 4. Most Match Points-Total, 5. Most Take Downs, 6. Most Reversals, 7. Most Escapes). (Amended 9/09/17)
- e. The tournament draw will be held at the **September** meeting. (Amended 4/13/18)
